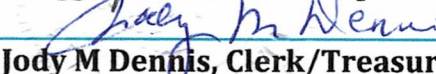

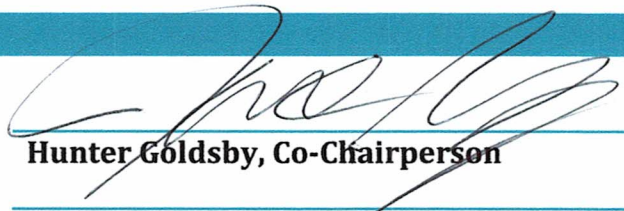
ADJOURN: A motion to adjourn was made by Bill Drake and seconded by Hunter Goldsby.
